

## **Communication N° 1 (Amended) 2024 FIA Motorsport Games Cross Car Junior**

**Published by the FIA on 03 September 2024**

The following communication is intended to provide information and clarify frequently asked questions regarding the registration for the Cross Car Junior (XC Junior) category at the Motorsport Games 2024. The information in this communication serves as a guideline to be considered when completing the entry form. For the complete information, please read the XC Junior Sporting Regulations, which can be downloaded via the following link:

### **1. Competitor's information:**

- The competitor must be a legal entity or a physical person, holding a valid International Competitor's license and the necessary authorisation issued by their ASN. In case of a physical, the competitor must be minimum 18 years old. The name of the competitor must be in the competitor's license.
- Since in the XC Junior category, the drivers are minors, the competitor cannot be the driver.
- The information regarding license number, country and issuing ASN must match the photo of the license uploaded, which must be clear and legible.
- In case the competitor wants to nominate a representative, this must be the person that will attend the FIA Motorsport Games 2024 in person and will be accompanying the driver.
- In case the competitor is a physical person, but cannot attend to the FIA Motorsport Games 2024, the competitor must fill the representative data (physical person) and send a letter to [rquintanilla@fia.com](mailto:rquintanilla@fia.com), indicating that the representative is going to represent the competitor.
- In case the competitor is a legal entity, the competitor's license must have the name of the legal entity and the representative must be a physical person within the legal entity or a person outside the legal entity that has a letter being authorized to be the representative. This letter must be sent to [rquintanilla@fia.com](mailto:rquintanilla@fia.com).
- The photo of the competitor representative must be of good quality, with a neutral background and avoiding the use of helmets or any other implement that might interfere with the identification of the competitor. If the competitor is going to attend the event, and will not assign a representative, the competitor must fill the "competitor representative" with its own information and picture.

### **2. Driver's information:**

- The first and last names of the driver declared, as well as the driver's ID number, must match with the photocopy of driver's ID. It should be noted that the driver must be between 13 and 16 years of age at the time of the start of the competition.

- The required identity document can be an ID card or the passport, however, we strongly recommend using the passport, so that we can verify that there are no problems with the travelling, even if it is the full responsibility of the driver. This document must be legible and of a good quality.
- The driver's license must be of ITG grade or higher, the number of which must match the document uploaded on the platform. If you do not have a physical license, please upload a digital license or a validation that allows us to verify the validity of the license.

### **3. Vehicle information:**

The vehicle information to be declared must be in accordance with the Technical Regulations for Cross Car, complying with the following conditions:

- Chassis of the vehicle: The chassis of the vehicle declared on the registration platform must be one of those listed in Appendix 1 of the Technical Regulations for Cross Car (pages 32-33) and must hold an FIA Technical Passport (Art. 9.1.3 of the MSG Cross Car Competition Sporting Regulations).
- Engine of the vehicle: The engine of the vehicle declared on the registration platform must be the “Yamaha MT07: 2023-06-XCAR-MT07” (page 35 of the Technical Regulations for Cross Car (Appendix J 2024 – Article 279B), which can be found in the following link: [https://www.fia.com/sites/default/files/279b\\_2024\\_wmsc\\_2024.06.11\\_khg.pdf](https://www.fia.com/sites/default/files/279b_2024_wmsc_2024.06.11_khg.pdf) ) and must be in accordance with the provisions of the corresponding Homologation Form including ECU and exhaust, which can be found in the following link: <https://www.fia.com/regulation/category/102>, under the “Related Homologations” section.
- Please note that if you are renting a vehicle, fill in as much information as possible regarding the engine and chassis model and, for any other unknown data at time of registration, indicate in the other fields "to rent" so that we are aware of this situation. Please also indicate from whom you will be renting the vehicle.

### **4. Competition authorisation for minors:**

As the XC Junior category is for drivers aged 13 and 16 years old, by FIA regulation, it is imperative that the driver's parents or legal guardians complete and sign a letter of authorisation for the driver to compete in the XC Junior category during the Motorsport Games 2024.

Once the registration has been completed, via the Motorsport Games platform, the signed authorisation document must be sent to the FIA.
